

MB Type One-Person Font License

- (1) This license covers one person: you, the license owner. Below, I'll shorten this to "you."
- (2) I, Matthew Butterick (d/b/a MB Type), own the fonts delivered with this license. Below, I'll refer to these licensed fonts as "my fonts."
- (3) This license is non-exclusive and non-transferable. It takes effect the first time you install my fonts. It applies to my fonts and any free updates to my fonts. I reserve all rights that I have not granted you in this license.
- (4) Subject to the limitations below, you can:
 - (4)(a) Install my fonts on any computing devices dedicated exclusively to you. An account on a multi-user server qualifies as a computing device.
 - (4)(b) Use my fonts in any way you like, including, of course, printed documents.
- (5) You can't distribute copies of my fonts to unlicensed users, but you can embed my fonts as follows:
 - (5)(a) You can embed read-only versions of my fonts in digital files you create, including PDFs, e-books, software applications, and websites (as webfonts). "Read-only" means that those who use your digital files can neither install my fonts nor use them to make new documents.
 - (5)(b) You can embed read/write versions of my fonts in word-processing documents you create that will be shared with fewer than 20 people.
 - (5)(c) These embedding rights don't extend to files or websites you create on behalf of third parties (e.g., as an external designer or developer). Third parties need to get their own license.
- (6) You can modify my fonts, including converting them to other formats (including webfonts) but my copyright and trademark notices must remain intact. You can install and use these modified fonts under the same terms. No technical support is available for modified fonts.
- (7) This license remains in effect until terminated.
 - (7)(a) You can terminate this license by sending me a request for termination along with confirmation that you've deleted all copies you've made of my fonts, including embedded copies. If you terminate within 30 days of your initial order, I'll refund your license fee.
 - (7)(b) If you breach this license, it will automatically terminate.
 - (7)(c) If you have unusual or excessive technical-support needs, I can terminate your license by refunding your license fee.
- (8) None of the descriptions of my fonts are legal advice.
- (9) California law governs this license. Courts in Los Angeles County, California have exclusive jurisdiction over claims arising under this license. You agree to service of process at the e-mail address on your original order.

- (12) If an organization paid for your license, the following terms also apply, and supersede conflicting terms elsewhere in this license:
 - (12)(a) An "organization" is an entity, or logical subdivision of an entity, with between two and 500 full-time employees.
 - (12)(b) Everyone in the organization who regularly edits documents that use my fonts needs a separate license.
 - (12)(c) You can use my fonts only for projects on behalf of the organization.
 - (12)(d) If you stop working for the organization, your license can be transferred to another person within the organization.
 - (12)(e) Webfont usage is allowed on up to three domain names that the organization owns.
- (13) If you modify my fonts, you can make copies of the modified fonts for others in the organization who also have a license to use my fonts.
- (14) This is the whole license. If part of the license turns out to be unenforceable, the rest will remain. The license can be changed only if we both agree in writing.
